**ARTICLES OF AMENDMENT TO
ARTICLES OF ORGANIZATION OF
LIBERTY VP REDWOOD, LLC
(A Florida Limited Liability Company)**

Pursuant to Section 608.411, Florida Statutes, **LIBERTY VP REDWOOD, LLC**, a Florida limited liability company (the "Company"), hereby adopts the following Articles of Amendment:

- FIRST:** The Articles of Organization were filed on March 23, 2007, and assigned document number L07000031523.
- SECOND:** Article I of said Articles of Organization is amended in its entirety to change the name of the Company from "**LIBERTY VP REDWOOD, LLC**" to "**LIBERTY VP WATERBURY, LLC**", by deleting the provision of said Article I as the same now exists and by substituting in lieu thereof, the following:

"ARTICLE I - Name

- THIRD:** All other provisions of the Articles of Organization remain unchanged and in full force and effect.
