The name of the limited liability company is: Presidential Marketing, LLC.

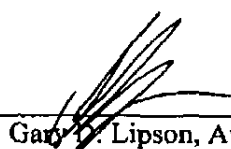
2. The date of adoption of the foregoing amendments to the Article of Organization is September 22, 2010.
