

The name of the Limited Liability Company (hereinafter referred to as "Company") is Northside Properties, L.L.C.


**ARTICLE II - PRINCIPAL OFFICE**

All accounting principles applicable to partnerships shall apply to this Company.


## **ARTICLE X - EVENTS OF DISSOLUTION**
