Pursuant to the provisions of Section 605.0202 of the Florida Statutes, the undersigned Florida Limited Liability Company hereby adopts the following Articles of Amendment to its Articles of Organization:

**Article I - Name and Date of Filing**

The name of the company is H&G ORTHOPAEDIC DEVELOPMENTS, LLC (hereinafter referred to as the "Company"). The Articles of Organization of Company were originally filed on March 27, 2007 as H&G Orthopaedic Developments, LLC. The Company's Florida document number is L07000032024.
