**Article 5 – Management**

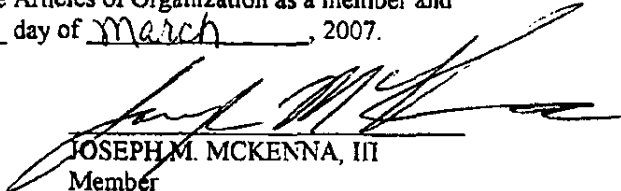
