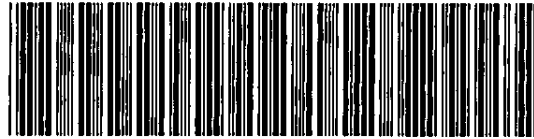

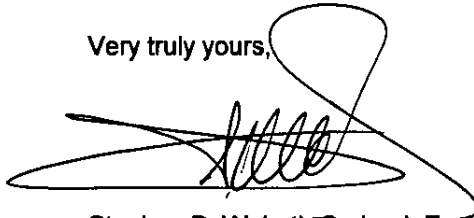

**Incapacity of a Member**

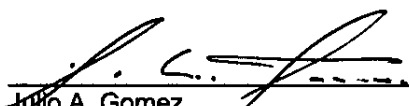
