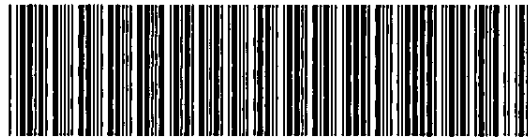

AMENDED AND RESTATED ARTICLES OF ORGANIZATION

The undersigned, being a duly authorized representative of a member, desiring to amend and restate the articles of organization of this limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Amended and Restated Articles of Organization:

ARTICLE I. NAME / FILING DATE

The name of the limited liability company is **CREATIVE PORTAL MEDIA LLC** (the "Company"). The Articles of Organization of the Company were filed on March 26, 2007, and assigned document number **L07000032517**.

ARTICLE II. ADDRESS

The principal office and mailing address of the Company is:

ARTICLE III. REGISTERED AGENT AND OFFICE

The Company designates 351 Virginia Street, Hollywood, Florida 33019 as the street address of the initial registered office of the Company and names Stuart Levy the Company's initial registered agent at that address to accept service of process within this state.

ARTICLE IV. MANAGEMENT

The Company is to be managed by one or more managers and is, therefore, a manager-managed company. The name and address of the initial manager is Stuart Levy, 351 Virginia Street, Hollywood, Florida 33019

ARTICLE V. DURATION AND CONTINUATION

The period of the Company's duration shall commence with the filing of these Articles of Organization with the Secretary of State, and shall continue perpetually, unless terminated by the written agreement of a majority of ownership interest.

ARTICLE VI. PURPOSE

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE VII. ADDITIONAL MEMBERS

Additional Members may be admitted upon the approval of a majority of the ownership interest of the Company, upon the written application of such new Member.

ARTICLE VIII. EFFECTIVE DATE

The effective date of these Amended and Restated Articles of Organization shall be the date that they are filed with the Florida Department of State.
