FIRST: The Articles of Organization were filed on March 2, 2007, and assigned document number L07000032527.

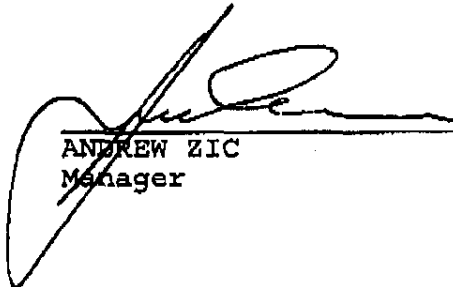
