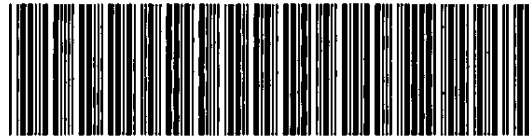

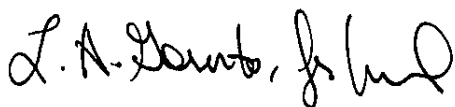

NAME

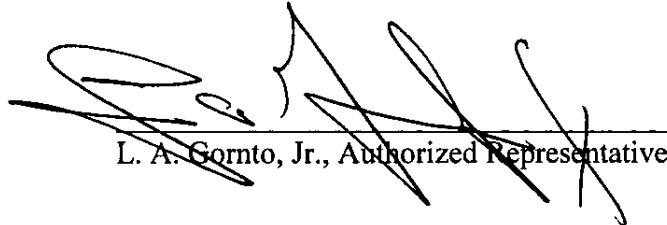
