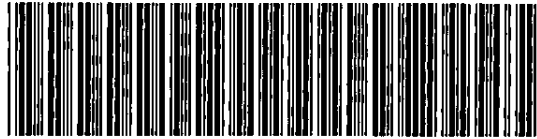


ARTICLE III


