ARTICLES OF ORGANIZATION OF C-3 OF NAPLES, LLC, a Florida Limited Liability Company

TALLAHASSEE. FLORESCEE. FLORESCEE

The undersigned, being the duly authorized representative of the initial members of a limited liability company to be organized under the Florida Limited Liability Company Act, adopted and submits the following Articles of Organization for such limited liability company:

ARTICLE I

The name of the limited liability company is C-3 OF NAPLES, LLC, a Florida limited liability company (the "Company").
