**ARTICLES OF ORGANIZATION
OF
JSW COLONIAL PROPERTIES, LLC**

The undersigned authorized agent of the initial Members of the limited liability company hereby certify that the Members, for the purpose of forming a limited liability company under the laws of the State of Florida, hereby organize a limited liability company to provide for the formation, rights, privileges, and immunities of a limited liability company for profit. I further declare that the following Articles shall be the Charter and authority for the conduct of business of such limited liability company.

**ARTICLE I
NAME**

affairs of the Company not inconsistent with law, this Instrument and the Florida Limited Liability Company Act.


ARTICLE VI
