ARTICLES OF ORGANIZATION

<u>of</u>

a Florida Limited Liability Company

FIRST: The name of the Limited Liability Company shall be LAKESIDE GROUP HOME, L.L.C. (hereinafter referred to as the "Company").

SECOND: The mailing address and street address of the principal office of the Limited Liability Company is 1605 Main Street, Suite 1001, Sarasota, Florida 34236.

THIRD: The duration of the Company's existence shall be perpetual.

<u>TENTH:</u> Whenever income is earned by the Company, there shall be, at a minimum, sufficient distribution of income to its Members to allow them to pay, on a timely basis, all of
