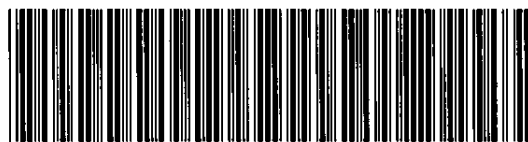

ARTICLES OF ORGANIZATION

OF

This company will be a manager-managed company managed by one of its members in accordance with and subject to the requirements of the Act and the operating agreement of this Company.

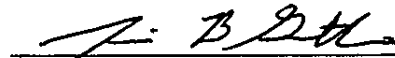
ARTICLE V: PURPOSE
