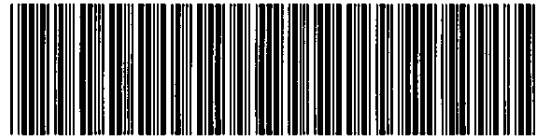

ARTICLE VIII - Registered Agent:


