The undersigned adopt the following Amended and Restated Articles of Organization pursuant to the authority and provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act:

FIRST: The name of the limited liability company filing these Amended and Restated Articles of Organization is MLY, LLC (the "Company").

SECOND: These Amended and Restated Articles of Organization were approved by the Members.


