**AMENDED AND RESTATED  
ARTICLES OF ORGANIZATION****OF****LANE, WITHERSPOON & CARSWELL

The undersigned authorized representative executes these Articles of Organization to form a limited liability company under the Florida Limited Liability Company Act:

**ARTICLE I. NAME**

The name of the limited liability company is Lane, Witherspoon & Carswell Commercial Real Estate Advisors, LLC.

**ARTICLE II. ADDRESS**

The mailing and street address of the principal office of the limited liability company is 1715 N. Westshore Boulevard, Suite 130, Tampa, FL 33607.

**ARTICLE III. REGISTERED AGENT AND OFFICE**
