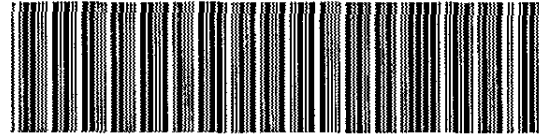

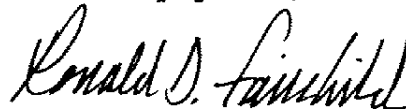

ARTICLES OF ORGANIZATION
OF
McCLOW PROPERTIES, LLC

The undersigned, for the purpose of forming a limited liability company under the laws of Florida, hereby adopts the following Articles of Organization:

ARTICLE I

NAME
