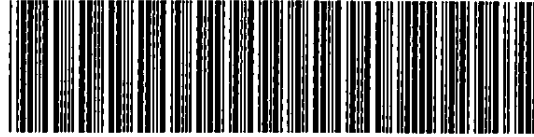

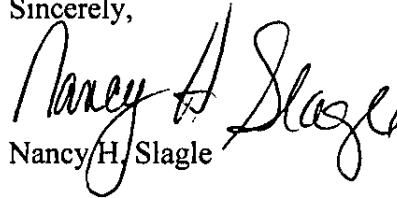

**ARTICLES OF ORGANIZATION
OF
VIRTUAL SOLUTIONS 4 U, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I
NAME**

The name of the limited liability company shall be **VIRTUAL SOLUTIONS 4 U, LLC** ("Company"). Company not inconsistent with law or these Article of Organization. The name and address of the initial Managing Member of the Company is:

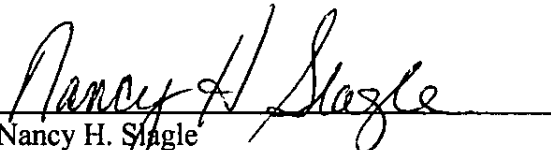

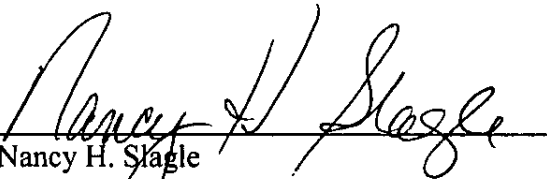
