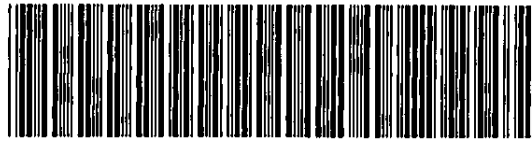

**ARTICLES OF ORGANIZATION  
OF**

**UNIT 807, L.L.C.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I -- NAME**

The name of the limited liability company shall be UNIT 807, L.L.C. ("company")

**ARTICLE II -- ADDRESS**

The mailing address and street address of the principal office of the company shall be: **700 West First Street Sanford, FL. 32771**

**ARTICLE III -- DURATION**

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is earlier dissolved as provided in these articles of organization.

**ARTICLE IV -- REGISTERED OFFICE AND AGENT**

The name and street address of the registered agent of the company in the state of Florida is: **GEORGE B. WALLACE, 700 West First Street, Sanford, Florida 32771.**

**ARTICLE V -- ADMISSION OF NEW MEMBERS**

No additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on such terms and conditions as shall be determined by all the members. A member may not transfer his or her interest in the company except as set forth in the regulations of the company.

**ARTICLE VI -- TERMINATION OF EXISTENCE**

The company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by the consent of all the remaining members, provided there are at least two remaining members.


