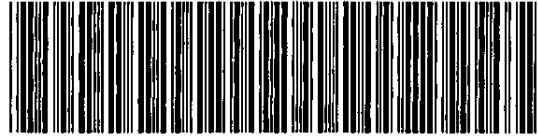


ARTICLE VII

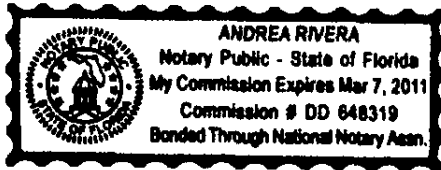


