**ARTICLES OF ORGANIZATION OF
HULL ENTERPRISES, LLC**

Article I

The name of the limited liability company ("Company") is HULL ENTERPRISES, LLC.

Article II

The mailing and street address of the Company's principal office is 1836 John Anderson Dr., Ormond Beach, Florida 32176. The members shall have the power and authority to establish branch offices, or to change the location of the principal office, to such other places as the members may designate.
