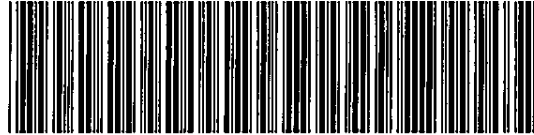

There shall be one Managing Member of the LLC and his name and address are as follows:






