**ARTICLE I - NAME**

The name of the limited liability company is:

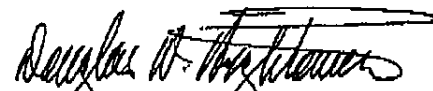
ARTICLE IX - AMENDMENT

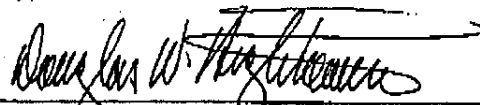
