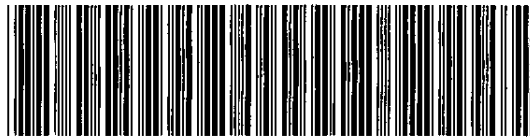

Please find enclosed my resignation from Crossline LLC and Creative Investments of Ocala, as well as my husband Richard Paquette's, resignation from the same LLC's. The reasons for our decision to resign from these companies are:

1. The LLC's have not had one single meeting of the members. We have no idea what our duties were suppose to be or even what portion of the businesses we owned.
2. Also all mail goes to the business addresses even though our names are on several loans and the credit cards were all applied for by my husband or me.
3. We are not privy to the financial aspects of the company and do not feel comfortable about the way that Crossline does business. In my eyes it is not ethical and probably fraudulent.

I have on numerous occasions, asked that we have meetings to question some of the LLC's business practices, but, I keep getting put off.

Since we guaranteed the loans on several vehicles as well as several credit cards, and we haven't received any money from the businesses (except a check for thirty thousand dollars that bounced), we've tried not to "upset the apple cart", but I can see that this will be a never ending process of trying to "do the right thing". Apparently, the banks, credit card companies, and other businesses have been receiving late pays or bad checks for months now.

I have been in contact with several of them and I'm working with them to get the vehicles back to them as quickly and smoothly as possible. I'm also trying to contact the credit card companies to notify them of the situation. Unfortunately, by the time we realized that we weren't the only ones not being paid, we had already invested the rest of our money into these companies.

Since I am disabled and my husband has been out of work since an automobile accident last year, we have pretty much been living on our life savings which, are now all gone.

We just want to disassociate ourselves from Ira Gilroy, Crossline LLC, and Creative Investments of Ocala.
