**ARTICLES OF ORGANIZATION

Pursuant to the provisions of Chapter 508 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State, the following are the Articles of Organization for THE CHART GROUP, LLC (the "Company"):

1. Name. The name of the Company is THE CHART GROUP, LLC.
