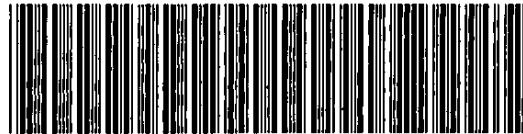

Attachment to Articles of Amendment to Articles of Organization of Festcon, LLC

1. Article IV (also referred to as Article 4) of the Articles of Organization is hereby amended in its entirety to provide as follows:

"ARTICLE 4 -- DURATION

Subject to the provisions of Article 8, the Company's existence shall be perpetual, unless the Company is earlier dissolved as provided in these Articles of Organization."

2. Article 9 of the Articles of Organization is hereby amended in its entirety to provide as follows:

"ARTICLE 9 -- MANAGEMENT

The Company shall be managed by a manager or manager(s) in accordance with an operating agreement adopted by the Members. The operating agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
