ARTICLES OF ORGANIZATION OF C & S GREENLAWN MAINTENANCE, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be C & S GREENLAWN MAINTENANCE, LLC, ("company").

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the company is 37900 Burhans Rd., Eustis, FL 32726.

ARTICLE III - DURATION

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company. The business may be continued only on the unanimous written consent of the remaining members.

ARTICLE VIII - MANAGEMENT

The company shall be managed by the members in accordance with Operating Agreement adopted by the members for the management of the business and affairs of the company. This Operating Agreement may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization.
