**ARTICLES OF ORGANIZATION

1. Name. The name of this limited liability company is **NO BOUNDARIES FAMILY ENTERPRISES, LLC**, a Florida limited liability company (the "**Company**"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.
