**ARTICLES OF ORGANIZATION
OF

**ARTICLE I

MANAGEMENT (MANAGEMENT BY ITS MEMBERS)**


The Company shall be managed by its Members, in accordance with regulations adopted by the members for the management of the business and affairs of the Company. These regulations may
