The name of the Company is 2368 TUSCAVILLA ROAD, LLC.

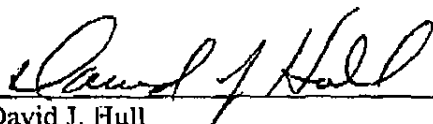

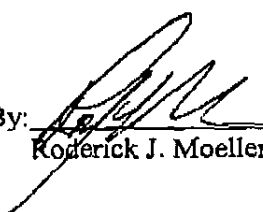
