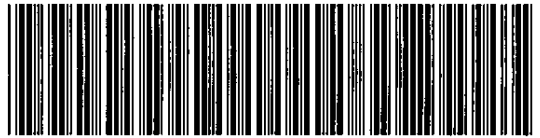

members.


