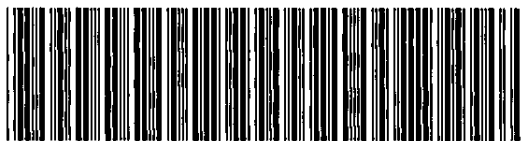

ARTICLE VPURPOSE


The nature of the business and of the purposes to be conducted and promoted by this limited liability company, is to engage in the following activities:


