WHEREAS, the Members of the Company have recommended the amendments to the Articles of Organization set forth below; and

WHEREAS, the undersigned Company, by and through its Members and pursuant to the provisions of Section 608.411 of the Florida Statutes, unanimously agreed to amend the aforesaid Articles of Organization in the manner hereinafter set forth;

NOW, THEREFORE, the undersigned hereby amends the Articles as follows:

1. Change the incorrect spelling of the Managing Member's name set forth in the 2008 Limited Liability Company Annual Report from SRD Real Property Holdings, LLC to Specialty Restaurant Development, LLC.
2. Change the incorrect spelling of the Registered Agent name set forth in the 2008 Limited Liability Company Annual Report from Roetzel & Anderess C/O Michael Furbush to Roetzel & Andress, LPA C/O Michael Furbush.
3. The date of the foregoing amendment's adoption shall relate back to the filing of the 2008 Limited Liability Company Annual Report.
4. Except as modified herein, the Articles of Organization of said Company shall be and remain in full force and effect.
