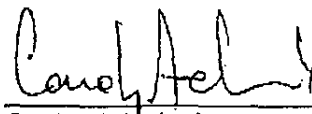
4. COMPANY OBLIGATIONS. Adequate provision has been made for payment of all debts, obligations and liabilities of the Company.

5. COMPANY PROPERTY. All the remaining property and assets of the Company have been distributed among the Members in accordance with their respective rights and interests.

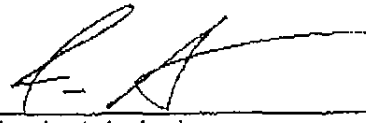
6. CONSENT OF ALL MEMBERS. The Dissolution is with the written consent of all of the Members pursuant to Florida State §605.0701(2).
