ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company understhe Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby of makes, acknowledges, and files the following Articles of Organization.

<u> ARTICLE 1 - NAME</u>

All references in these Articles of Organization to "member", "manager", "employee" and "agent" shall include the heirs, estates, executors, administrators and personal representatives of such persons.
