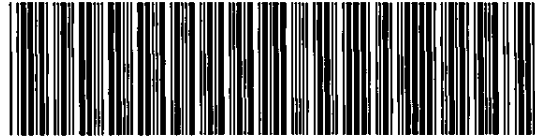

ARTICLE 1.
NAME

INITIAL REGISTERED OFFICE AND REGISTERED AGENT




