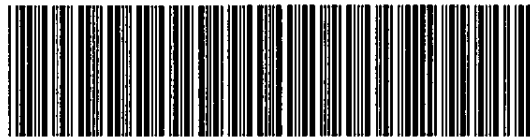



**ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a professional limited liability company under the Professional Service Corporations and Limited Liability Companies Act, F.S. Chapter 621, hereby make, acknowledge, and file the following Articles of Organization:

**ARTICLE I – NAME**

The name of the limited liability company is DRAPER LAW GROUP, P.L.

**ARTICLE II – ADDRESS**


## ARTICLE VI – DURATION
