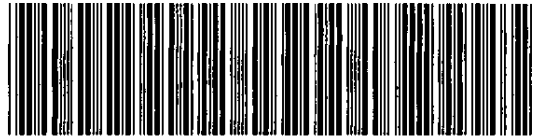

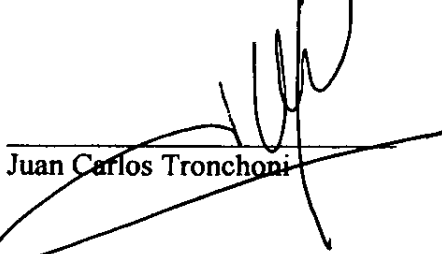
**ARTICLES OF DISSOLUTION

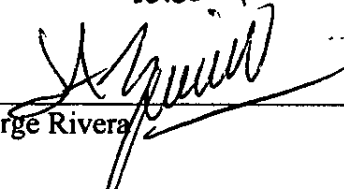
