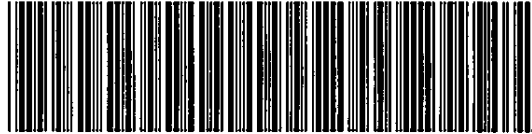

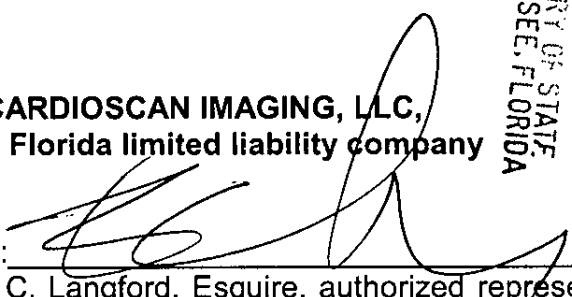
FIRST: The date of filing of the Articles or Organization was April 10, 2007.
