**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF ORGANIZATION  
OF  
EXPEDITED TRAVEL, LLC**

The provisions of the Articles of Organization of Expedited Travel, LLC, a Florida limited liability company (the "Company"), filed with the Department of State, State of Florida on April 10, 2007, as amended and restated by the Amended and Restated Articles of Organization filed with the Department of State, State of Florida on March 20, 2008, are hereby amended as follows:

- A. Article I shall be deleted in its entirety and the following inserted in lieu thereof:

**ARTICLE I  
NAME**

The name of the limited liability company shall be "Expedited Travel Holdings, LLC" (the "Company").

- B. Article III shall be deleted in its entirety and the following inserted in lieu thereof:

**ARTICLE III  
MANAGEMENT**

The management of the Company shall be vested in one or more managers. The Company is to be a manager-managed company.
