## ARTICLES OF ORGANIZATION OF R & D PROPERTIES, L.L.C.

The undersigned, for the purpose of forming a limited liability Company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### **ARTICLE I - NAME**

The name of the limited liability Company shall be R & D Properties, L.L.C. ("Company").

#### ARTICLE II - ADDRESS OF PRINCIPAL OFFICE

The mailing and street address of the principal office of the limited liability Company 557

Caro Court, New Smyrna Beach, FL 32168.

#### **ARTICLE III - DURATION**

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall terminate not later than perpetual, unless the Company is earlier dissolved as provided in these Articles of Organization.
