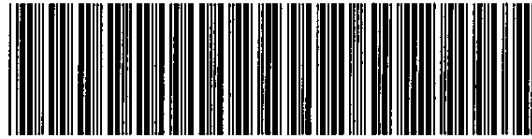

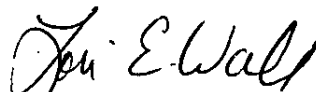

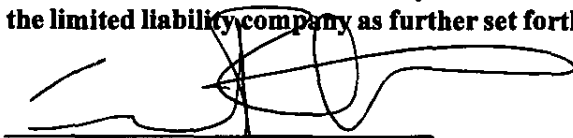

1. **Name.** The name of the limited liability company is Eola Rose Development, LLC

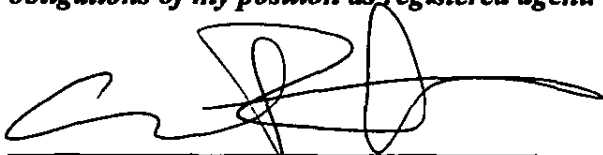
