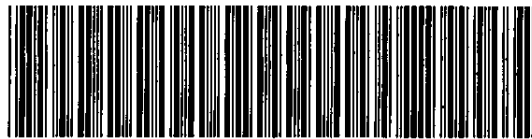


ARTICLE VIII


