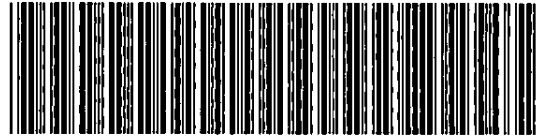

ARTICLE 1.  
NAME


