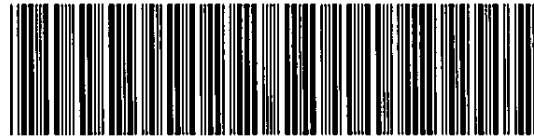

The mailing address and street address of the principal office of the Limited Liability Company is **4424 New Broad Street, Orlando, FL 32814**.

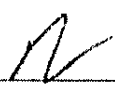
Article III
