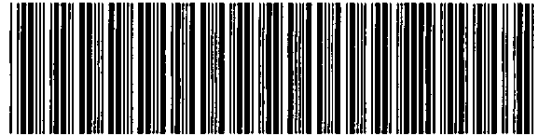

ARTICLES OF ORGANIZATION
OF
EFFIE'S CULINARY DELIGHTS, LLC

ARTICLE I - NAME

The name of the limited liability company shall be EFFIE'S CULINARY DELIGHTS, LLC. ("Company").

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the Company in Florida shall be 5029 Rock Rose Loop, Sanford, FL 32771.

ARTICLE III - DURATION

The period of duration of the Company shall be perpetual commencing on the date these Articles of Organization are filed by the Florida Department of State unless the Company is earlier dissolved as provided in these Articles of Organization or the Operating Agreement of the Company.

ARTICLE IV - PURPOSES AND POWERS

The general purpose for which the Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

ARTICLE V - REGISTERED OFFICE AND AGENT

ARTICLE VI - ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and upon such terms and conditions as shall be set forth in the Operating Agreement of the Company.

ARTICLE VII - TERMINATION OF EXISTENCE

The Company shall be dissolved upon the bankruptcy or dissolution of a member, or upon the occurrence of any other event that terminates the continued membership of a member in the Company as provided in Section 608.441, Florida Statutes, unless the business of the Company is continued by the consent of all the remaining members, provided there are at least two remaining members (except in the event a single member is permitted under F.S., Chapter 608 and the Company with a single member is treated as a pass-through entity for federal income tax purposes).

ARTICLE VIII - MANAGEMENT

The Company shall be managed by one or more managing members in accordance with the Operating Agreement adopted by the members for the management of the business and affairs of the Company. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization. The name and address of the initial managing members of the Company are:

ARTICLE IX - RETURN OF CAPITAL

No member may demand return of capital contributions except as may be provided in the Operating Agreement of the Company.


