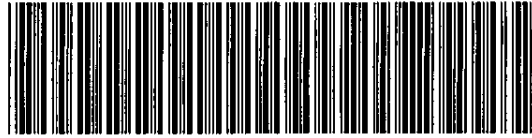

ARTICLES OF ORGANIZATION

OF

ELITE VINYL PRODUCTS OF TENNESSEE, L.L.C.

ARTICLE I - NAME

THE NAME OF THIS Limited Liability Company shall be **ELITE VINYL PRODUCTS OF TENNESSEE, L.L.C.**

ARTICLE II - ADDRESS

THE MAILING ADDRESS and street address of the principal office of the Limited Liability Company shall be 921 26th Avenue E, Bradenton, Florida 34208.

ARTICLE III - DURATION

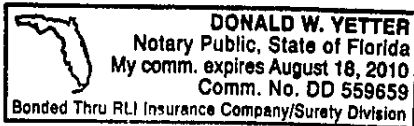


