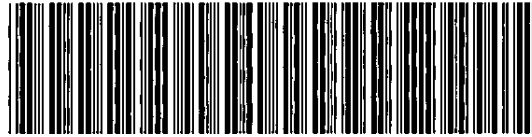

AMENDED ARTICLES OF ORGANIZATION
OF
KARIN S HOTCHKISS MD PA LLC

Karin S Hotchkiss MD PA LLC (the "Company") in accordance with the Florida Business Corporation Act, the Florida Professional Service Corporation and Limited Liability Company Act, hereby amends its Articles of Organization in its entirety and hereby adopts the following Amended Articles of Organization:

ARTICLE I.
NAME

The name of the Professional Limited Liability Company shall be Karin S. Hotchkiss, M.D., P.L.

DURATION; EFFECTIVE DATE

ARTICLE VI
RESTRICTIONS ON MEMBERSHIP;

Members must be licensed to practice medicine in the State of Florida. A member's interest in the Professional Limited Liability Company may not be sold or otherwise transferred except to a person licensed to practice medicine in the State of Florida and only in accordance with the provisions of the Operating Agreement of this Professional Limited Liability Company.

The Amended Articles of Organization have been adopted by written action of the sole member of the Company pursuant to Section 608.4231, Florida Statutes, which vote was sufficient for approval.
