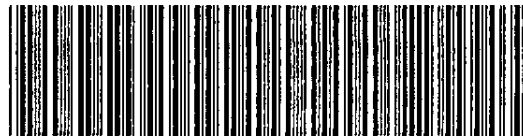



These Articles of Organization may be amended or repealed upon the unanimous approval of then existing Members of the Company.


